## (Alleged) Characteristics and Values

- Narcissism
- Entitlement/Laziness
- Consider themselves the authority
  - "Hyper" educated
  - Youth more of an asset than age/experience (technology driven economy)

- Collaborative

# More (Alleged) Characteristics and Values

- Fairness
- Corporate transparency
- High expectations for government/embrace "the system"
- Pragmatic
- Optimistic
- Financially responsible
- "Are women the new men?"

### **Pro-Plaintiff?**

- "Liberal"
- Focus on fairness = focus on feelings over facts?
- Relate to those out of work



### **Pro-Defense?**

- · Highly educated
- Considered pro-business
  - Not nearly as distrustful of corporations as prior generations
  - Resourceful and entrepreneurial themselves; like that businesses create things they like
- High narcissism = lack of empathy
  - Reserved, not passionate



#### Pro-Defense?

- Some jury consultants believe Millennials are more defense-oriented
  - "What we are seeing in a lot of med-mal and personal injury cases is [Millennial] jurors asking why [the plaintiff] didn't get a second opinion." [LaVerne Morris, Jury Consultant with TrialGrahpix]
  - Millennial jurors are generally more prone to question a plaintiff about what actions he or she took that might have ignited the complaint. [LaVerne Morris, Jury Consultant with TrialGrahpix]

## **Voir Dire Tips for Millennials**

- Take advantage of online information
  - Ask whether they write or contribute to blogs
  - Internet research
- Start a conversation
  - Less talking, more listening
- Tone down argument
  - Think more highly of their own thoughts than of yours
- Avoid interrogating



- Embrace technology and multimedia
  - Make your presentation interactive; entertain
- · Speak in "sound bites"
- Streamline your case presentation/ narrow themes
  - Short attention span
- Focus on collaboration and fairness





### More Trial Tips for Appealing to Millennials

- Focus less on credentials
- Fulfill their interest in being educated
- Explain issues of reliability of evidence
  - Do not necessarily appreciate that the source of much of their information, the internet, is not always reliable
- Lead them to your conclusion, rather than telling them what to think
